CALL TO ORDER AND ANNOUNCEMENT OF QUORUM

Vice-chair Cuquet called the meeting to order at 8:30 am. He announced there was a quorum.

Vice-chair Cuquet led the Pledge of Allegiance and gave the evacuation procedure instructions.

Vice-chair Cuquet noted that, as the agenda stated, members of the public would be allowed to address the Executive Committee on any agenda item prior to the Committee's decision on that item. ADMINISTRATION

Meetings attended on behalf of the JPIA None were noted.

Central Basin Municipal Water District

Central Basin Municipal Water District's participation in the Liability, Property, and Workers' Compensation Programs was terminated in May 2014, by the decision of the Board of Directors. The District continues with participation in the Employee Benefits Programs.

Kevin Hunt, Central Basin Municipal Water District's General Manager, and Dina Hidalgo, Human Resources Manager, addressed the Executive Committee on the progress of the changes that the District has made and to request consideration of full reinstatement back into the Liability, Property, and Workers' Compensation Programs effective July 1, 2017.

There was discussion on this request, and the Executive Committee asked that this item be brought back to the next meeting on March 21, 2017.

Executive Committee Per Diem

Mr. Sells stated that Government code allows for an annual maximum increase to the daily Per Diem rate of 5%. The last increase to the Per Diem rate was February 9, 2016. The current daily rate of Per Diem for Executive Committee members and Directors attending program committee meetings is \$267.99. The maximum increase of 5% would increase the rate to \$283.39, effective February 7, 2017. This is a standing agenda item for the first Executive Committee meeting of each calendar year.

FINANCE

Governmental Accounting Standards Board (GASB) 68

Mr. deBernardi relayed that the JPIA provides for a defined benefit plan to its employees upon retirement through CalPERS. Benefit provisions under the plan are established by State statute and ACWA JPIA resolution.

The JPIA recently received new contribution rates determined by CalPERS actuaries effective July 1, 2017. With this information, CalPERS provided the JPIA with its funded position in the plan, including an estimate of JPIA's portion of the market value of the plan's assets and accrued pension obligation.

Staff recommended that the Executive Committee approve funding the estimated pension obligation of \$1.348 million.

Rate Stabilization Fund Refunds

Mr. deBernardi reported that the 2012-13 policy year for the Liability Program will go through the retro process for the first time. This policy year has been very favorable to date. Consequently, the JPIA will refund \$4.5 million to members. The 2012-12 policy year for the Liability Program is the catalyst for the member refunds this year.

Staff provided a handout at the meeting with a detailed listing of member refunds.

MEMBERSHIP

Root Creek Water District

Ms. Watkins presented Root Creek Water District's application for admission to the Property Program. The District was formed in 1996 and is managed by Provost & Pritchard Engineering Group.

The District covers approximately 9,220 acres. Construction on the concrete pipeline, turnouts, storm water drain and wells began in 2014-15. The water delivery system has been built: inlet structure on the Madera Irrigation District Canal, and an outlet structure to empty into Root Creek, basically a flood channel.

A service plan has been developed to assist the agency with risk management recommendations. Staff recommended approval for admission.

Main San Gabriel Basin Watermaster

Ms. Kyburz presented Main San Gabriel Basin Watermaster's application for admission into the Liability, Property, and Workers' Compensation Programs.

The Main San Gabriel Basin Watermaster is charged with administering adjudicated water rights, along with management and protection of groundwater resources within the watershed and groundwater basin known as the Main San Gabriel Groundwater Basin in Los Angeles County. The majority of their operations are handled in the office. Three employees will attend outside meetings, producers' ribbon cutting, or visit producers' well drilling jobsite.

A service plan has been developed to assist the agency with risk management recommendations. Staff recommended approval for admission.

M/S/C (McDonald/Drake) (Cuquet-Yes; Drake-Yes; Gladbach-Yes; Hastey-Yes; Hodgin-Yes; Knutson-Yes; McDonald-Yes; Rupp-Yes): That the Executive Committee approve Main San Gabriel Basin Watermaster's application for admission into the Liability, Property, and Workers' Compensation Programs.

Sonoma Mountain County Water District

Ms. Kyburz presented Sonoma Mountain County Water District's application for admission into the Workers' Compensation Program.

Sonoma Mountain County Water District was formed in 1963, and services 55 homes within its boundaries. The District's water source is obtained from two wells and stored in three redwood storage tanks. Distribution system is a gravity feed system. The District has two part-time employees (general manager and water operator) and a five-member Board.

A service plan has been developed to assist the agency with risk management recommendations. Staff recommended approval for admission.

M/S/C (Rupp/Drake) (Cuquet-Yes; Drake-Yes; Gladbach-Yes; Hastey-Yes; Hodgin-Yes; Knutson-Yes; McDonald-Yes; Rupp-Yes): That the Executive Committee approve Sonoma Mountain County Water District's application for admission into the Workers' Compensation Program.

Chino Basin Desalter Authority

Ms. Smith presented Chino Basin Desalter Authority's application to join the JPIA to implement the JPIA medical, dental, vision and life plans.

The Chino Basin Desalter Authority is a joint exercise of powers agency formed between Jurupa Community Services District, the Santa Ana River Water Company, the Cities of Chino, Chino Hills, Norco and Ontario, Western Municipal Water District and the Inland Empire Utilities Agency.

Chino Basin Desalter Authority has six employees, three of whom are full time benefitseligible employees. Coverage in the JPIA Employee Benefits plans would become effective March 1, 2017. The Authority presents a favorable risk profile consistent with JPIA membership.

ACWA JPIA Central Basin Municipal Water District Presentation March 21, 2017

BACKGROUND

Central Basin Municipal Water District's participation in the Liability, Property, and Workers' Compensation Programs was terminated in May 2014, by the decision of the Board of Directors. The District continues with participation in the Employee Benefits Program.

CURRENT SITUATION

At the February 7, 2017 meeting, Central Basin's general manager, Kevin Hunt, requested that the Executive Committee consider full reinstatement into all three JPIA pooled programs. Mr. Hunt pointed out the progress that the District has made and future plans for Central Basin Municipal Water District.

Since that meeting, there have been significant events at the District that will be open for discussion.

Staff recommends against readmission into the JPIA's Liability, Property, and Workers' Compensation joint pooled protection programs.

RECOMMENDATION

That the Executive Committee vote whether to accept Central Basin Municipal Water District's request for full reinstatement into the JPIA's Liability, Property, and Workers' Compensation joint pooled protection programs.

Central Basin Municipal Water District - Loss Data

Tony Perez, former General Manager All directors involved, not tendered to the JPIA District paid \$700,000 no available information on cost of suit.

New Central Basin Water Board Ousts Phil Hawkins as President, Replaces with Bob Apodaca

Hews Media Group-Community News has learned that William Gedney, Mark Grajeda and John Oskoui, the three new Central Basin Water District Board members (CB) appointed last Wednesday, have sided and allied themselves with Directors Leticia Vasquez and Bob Apodaca and have voted to throw the operations of the embattled water agency into questionable territory once again.

The move has many questioning the motives of Gedney, Grajeda, and Oskoui who were appointed to the Board per the "mandate" of AB 1794, authored by Assemblywoman Cristin Garcia (D-Downey).

Vasquez is a "party plaintiff" in a whistleblower lawsuit against Central Basin that has cost the agency hundreds of thousands of dollars to defend. And, as documented by HMG-CN, Vasquez has a very checkered past since her election in 2012.

Apodaca recently had to settle a sexual harassment lawsuit that cost the district over \$1 million dollars after legal fees were factored in. HMG-CN also exclusively reported that Apodaca's common law wife was paid \$10,000 for "floral arrangements" provided at special events.

The "process" started during the Feb. 22 meeting where the Board voted 3-2 to investigate CB GM Kevin Hunt and his "questionable and covert" actions during the selection process of Messrs. Gedney, Grajeda, and Oskoui.

President Phil Hawkins, VP Pedro Aceituno and Director Art Chacon voted yes to investigate Hunt over the selection process, with Hunt allies Vasquez and Apodaca voting no.

A little over an hour later, after most Board members had left the building, Gedney, Grajeda, and Oskoui were hastily sworn in by Hunt inside the Board room without public notice.

Two lawyers that HMG-CN contacted said Hunt's actions were a violation of the Ralph M. Brown Act open meeting law because Hunt did not properly notice (place on a future Board agenda) the appointments to give the general public a chance to comment on the proposed new Board members.

The potential violation did not matter to Hunt, as the selection process ended up placing Gedney, Grajeda, and Oskoui on the Board.

One day later, CB published an agenda online scheduling the meeting for today.

Two agenda items called for "a reorganization of the Board and a review of the investigation into GM Kevin Hunt."

The new "voting block" Board followed through with the reorganization, removing Phil Hawkins, who was appointed president only one month ago, replacing him with the controversial Apodaca.

They also removed Hawkins from his Metropolitan Water District Board seat.

Aceituno remained at VP, while Vasquez and new Director Gedney were given seats on the Metropolitan Water District Board.

And in a move that could have future repercussions, Gedney, Grajeda, and Oskoui voted with Vasquez and Apodaca to stop the investigation into Hunt and terminate the contract with attorney Anthony Willoughby, who was heading the investigation.

On all items, Hawkins and Director Art Chacon voted no.

HMG-CN contacted Assemblywoman Garcia and CB for comment with no response as of publication time.

Central Basin Water GM Orchestrates Takeover of Water Agency, Appoints Board Members

Hews Media Group-Community News has exclusively learned that Central Basin Municipal Water District (CB) General Manager Kevin Hunt, who is under investigation for allegedly manipulating the selection process for new Board members, has initiated what can only be called a coup d'etat, orchestrating an attempt to take over of the board of directors and seize control of the Commerce based water agency.

It is a move reminiscent of the board takeover that Directors Leticia Vasquez, Bob Apodaca, and James Roybal pulled off in 2012.

Back then, Vasquez and Roybal won their respective seats, and, with the help of Apodaca, immediately removed then President Phil Hawkins and VP Art Chacon to take over the Board.

After that, the "Roybal Three" started down a trail of corruption and political payto-play schemes that have cost the agency millions of dollars.

And GM Hunt is trying a similar maneuver in a desperate attempt to secure power and keep his job.

The events unfolded after yesterday's special board meeting called to "discuss the future employment status of Hunt."

Sources have told HMG-CN that Hunt had manipulated the selection process of the newly created Board seats as outlined in Cristina Garcia's AB 1794 and was "getting called to the carpet for possible dismissal" at the meeting.

The Board ended up voting to investigate Hunt for his questionable actions, with current President Phil Hawkins, VP Pedro Aceituno and Director Art Chacon voting yes, and Hunt allies Vasquez and Apodaca voting no.

CB then hired Culver City based Anthony Willoughby to investigate Hunt and paid Willoughby a \$25,000 retainer.

Hunt was so incensed by the investigation that he immediately "summoned" the three new applicants and proceeded to swear them in as Central Basin Board members.

Immediately after that, Hunt's new board called for a special meeting next Monday February 27 to "reorganize the board."

The meeting will likely remove current President Hawkins and VP Aceituno and replace them with Bob Apodaca and Leticia Vasquez cementing Hunt's position.

But the meeting might not happen.

Hunt and CB has violated Section 54950 et. seq. of the Ralph M. Brown Act making the swearing-in of the new board members illegal.

Hunt and CB did not give proper public notice or opportunity for the action to be heard by the public.

The Brown Act mandates that an agency must post an action to an agenda and schedule a public meeting in order to give notice to the public of what the agency intends to do.

Hunt's actions after yesterday's board meeting was not posted, nor did the public have an opportunity to comment, which violates the Brown Act.

In addition, Hunt has violated provisions of AB 1794, which went into effect Jan. 1, 2017.

AB 1794 states, "The general manager of the district shall notify each water purveyor of the district and provide a 60-day period during which the district will accept nominations for appointment of individuals to the board of directors."

The 60-day period culminates on March 3, 2017 indicating Hunt had to wait until March 3 to start the appointment process.

HMG-CN has learned that lawyers representing Ron Beilke will file an emergency temporary restraining order either today to tomorrow to stop Hunt's actions.

Director of External Affairs Joseph Legaspi sent a comment from Hunt this morning, "The three successful candidates who resulted from a process that could take up to 60 days for nominations under the legislation was fully noticed, conducted in a public and transparent process with all documents being retained as public records. Over 30 of the purveyors responded with their ballot, a much higher participation rate than in general elections of directors by district. The actions of the process fulfilled both the intent and the letter of the law. Representatives from Assemblywoman Garcia's office were present and witnessed the open and transparent process and the high level of involvement throughout the appointment process."

When asked how the swearing-in was publicly noticed, Hunt responded, "The purveyors were noticed well in advance of all workshops discussing Assembly Bill 1794. Additionally, media releases were posted on our website and distributed to the media to keep the public informed of the process as it unfolded."

New directors for Central Basin bring back ousted president, cancel investigation contract

The three newest members of the Central Basin Municipal Water District on Monday helped bring swift change to the embattled agency, voting to reverse some of the actions a slim majority of the board's members ushered in over the last few weeks.

The trio of new directors — Mark Grajeda, William Gedney and John Oskoui — voted with two other board members to bring back Robert Apodaca, the board's former president who was ousted Jan. 23.

The additional directors come with state approval — Assemblywoman Cristina Garcia, D-Downey, wrote A.B. 1794, which increased the five-member board to eight, and tasked the 30 water utilities represented by the district to elect water professionals into the new seats.

The intent of the bill was to bring order to the board, which for years mishandled its leadership of the water district. Central Basin provides water services to millions of residents of nearly two dozen cities across southeast Los Angeles County.

A scathing audit in 2015 found the board approved inappropriate expenditures and displayed instances of bad management: board members spent lavishly on meals and travel to conferences, cycled through six general managers in five years, and broke state law by establishing a \$2.75 million trust fund with no public disclosure.

The addition of three directors dilutes the power of the board's previous majority, which voted out Apodaca and voted in one of its own, Phil Hawkins, as its new president before the new members were officially added.

"The issue for the new officers was that we saw the <u>president (Phil Hawkins)</u> throwing all the work we did out the window and not hearing (water utility officials)," said Grajeda, who is the general manager for the Pico Water District. "We just felt that we were going to have continual problems with that."

Those directors — Phil Hawkins, Pedro Aceituno and Art Chacon — also voted in a closed-session meeting last week to hire a law firm, Akin Gump, to investigate the election of the board's new members, which would have cost the district \$20,000.

The new board majority voted 6-2 to rescind that contract, with Aceituno joining them.

In his brief tenure as board president, Hawkins last week called a special meeting to consider firing General Manager Kevin Hunt. The move was meant to

prevent the general manager from counting the ballots in the election of the new board members. But the board ultimately was unable to act because Hunt was not notified in writing.

Aceituno, Chacon and Hawkins didn't return phone calls seeking comment.

The board also voted Monday to replace Aceituno and Hawkins as its representatives to the Metropolitan Water District board. Directors Leticia Vasquez and Gedney, an executive for the Golden State Water Company, will step in to those positions.

The new board still must deal with a <u>legal challenge</u> to A.B. 1794 filed by former Pico Rivera Councilman Ron Beilke. The lawsuit attempted to get a temporary restraining order of the law, but Los Angeles Superior Court Judge Amy Hogue rejected that argument on Friday.

In her ruling, Hogue questioned why Beilke hadn't brought his lawsuit sooner. She also supported the election of the new board members, saying the process had been open and thoughtful, according to a summary of the hearing prepared by Alfred Smith, an attorney for Central Basin.

"The judge indicated that she saw no evidence that the process would be detrimental, and there is a presumption that people whether elected or appointed will full and faithfully carry out their responsibilities," Smith wrote.

Michelle Iarusso, Beilke's attorney, in the lawsuit said the law violates the state election code "by substantially depriving voters in (the district) of the right to elect members of the CBMWD board of directors."

Beilke also did not return a phone call Monday seeking comment.
