The H.R. LaBounty Safety Awards Program is designed to promote safe workplace behavior and operations practices; and reward those employees who demonstrate safe behavior, take part in recognizable proactive activities, or participate in risk-reducing actions. As such, the Program gives members another way to foster a safety culture that reduces the potential for workers' compensation, liability, and property losses.

Tom Getman identified a potential safety hazard and liability risk at the South Well in Murrieta when vehicles leave the property due to blind spots on either side of the gate as a result of close-calls and near collisions. He discussed the hazard with Senior Operations Technician David Aranda to discuss a solution.

Recognizing that a pedestrian, bicycle rider or skateboarder could be struck as the vehicles are pulling out, he looked for ways to remind Western staff to be cautious and to alert those who may be in the blind spots.

Tom had considered installing convex mirrors, but cost and high potential of vandalism to the mirrors got him to think of another solution. The two came up with the idea to post a sign for staff reminding them to sound their horn before exiting the gate. He worked with Senior Operations Technician David Aranda, to get approval to purchase the sign, and when received, installed it himself.

The use of the sign and reminders to co-workers at the Murrieta Base has had a positive effect in preventing the vehicles pulling out and potentially hitting a pedestrian, skateboarder, or child on a bicycle.

Tom and David's ability to recognize a hazard, and the potential liability it could pose to the District, and to personally take steps to correct it is a reflection of their dedication to
