ACWA JPIA Selection of President and Vice President June 4, 2019

BACKGROUND

At the May 2011 Board of Directors meeting, the JPIA Bylaws were changed in regard to Executive Committee elections. An excerpt from the Bylaws, Article III, Section 1 reads:

"Commencing with the first Executive Committee meeting held after the 2013 Board of Directors' election, the Executive Committee shall appoint two of its members to serve two-year terms as President and Vice President of the Board of Directors. There shall be no limit to the number of two-year terms a person may serve as the President or the Vice President of the Board of Directors."

CURRENT SITUATION

At Spring Conference, seven candidates ran for four open positions on the Executive Committee. The two incumbents running were re-elected to four-year terms: President Gladbach and Director Rupp. Two new committee members were also elected to four-year terms: Fred Bockmiller from Mesa Water District, and Brent Hastey from Yuba Water Agency.

The terms and conditions of the JPIA's current Lloyd's of London form as well as APIP's reinsuring document will be amended to exclude Unnamed Miscellaneous Locations and add a member deductible based on their respective revenue for Cyber Liability.

Staff will provide further information at the meeting.
