Milestone Anniversary Celebrated At Spring Conference

The 2019 Spring Conference was held at the Marriott Hotel and newly renovated Convention Center in Monterey. Throughout the conference, the JPIA celebrated its

40th anniversary with the theme of strength • stability • partnership, celebrating 40 years. During the first day of the conference, there were two Program Committee meetings (Property and Workers' Compensation), followed by the Executive Committee meeting.

During the Pre-Board Meeting Lunch, JPIA CEO Andy Sells gave a presentation on the JPIA's history.

During the Board of Directors' meeting that afternoon, there were two elections held. The first one was the Executive Committee election, which filled four positions; two of which were currently vacant. After the final results of the Execu-

tive Committee election, there was an election to fill two positions on the California Water Insurance Fund board (an ACWA JPIA Captive Insurance Company). See the Election Results article on page 6 for more details.

Member Spot Light – Alameda County Water Agency And El Dorado Irrigation District

From the Bay Area to the Sierra Foothills, JPIA's expansion of membership into its suite of pooled programs continues! The JPIA is celebrating its newest members, Alameda County Water Agency and El Dorado Irrigation District into the pooled Property and Liability Programs.

Beginning in the Bay Area, in January 2019, Alameda CWA issued an extensive Request for Proposal (RFP) for its property and casualty products (i.e., general liability, property, and workers' compensation coverage). The JPIA replied to the RFP, earned an interview, and became the successful bidder. The District now participates in the JPIA's three pooled programs, along with dental and vision coverage from the Employee Benefits Program.

Since its 1914 inception, Alameda has grown in depth of service and influence in the San Francisco-East Bay area. The District was created to protect and be responsible for the Niles Cone groundwater basin. Jumping forward to 2019, 230 full-time employees are employed to provide care and reliability to the water systems, maintain reasonable pricing, and be stewards of Quarry Lakes Regional Recreation Area which is used for recharging the aquifers of the Niles Cone, just to name a few of the District's core activi-

ties. Alameda CWA serves 83,000 customers throughout the cities of Fremont, Newark, and Union City.

Now, traveling to the North Sierra Foothills where El Dorado Irrigation District is located, it was 1925 when El Dorado's story began. The El Dorado County residents voted to create the District to protect their water supply and maintain reasonable water rates. Jim Abercrombie, General Manger, recently stated "the District has transformed from a supplier of agricultural water, to a complex entity with five lines of business: water treatment and

delivery, wastewater collection and treatment, recycled water production and delivery, hydroelectric generation, and recreations services" (The Waterfront March-April 2019).

The District has 220 plus employees, over 1,500 miles of pipeline, and services more than 100,000 residents and multiple businesses.

El Dorado ID's expansion now includes the JPIA pooled Liability and Property Programs. It has been participating in the Workers' Compensation Program since 2007.

Alameda CWA and El Dorado ID fall into the top tier of the largest JPIA members. This "Smart Growth" initiative is indeed contributing to JPIA's continued success and growth.

\$4.5 Million In Refund Checks Distributed To Members
