PROGRAMS

<u>Wildfire Resiliency & Mitigation amendment to Commitment to Excellence</u> Ms. Thesing explained that in the past, the JPIA's most frequent and costly losses stemmed from auto, infrastructure, construction, employment practices, ergonomic, and fall related claims. Unfortunately, over the last three years, the pool has experienced a spike in fire losses, specifically wildfires which impact the liability, property, and workers' compensation programs.

The JPIA is encouraging its members to implement wildfire resiliency and mitigation programs that can reduce the severity of fire related claims.

Going forward, all new C2E inductees', will be required to incorporate wildfire mitigation plans. Staff will assist members to determine if they are in a wildfire prone area. This expanded loss driver will not only further protect JPIA members and their assets the program will speak to the reinsurance property market.

The effectiveness of the JPIA Commitment to Excellence is expected to be reflected in the long-term loss rate and cost statistics.



ACWA JPIA Infectious Disease Return to Work Policy June 1, 2020

BACKGROUND

On March 16, 2020, due to the COVID-19 outbreak, all staff were sent home from the JPIA office to shelter in place as dictated by the Governor. Government agencies have now begun to loosen the restrictions on returning to the office.

CURRENT SITUATION

As of May 8, 2020, the Governor's office, California Department of Public Health and Placer County have allowed employees to return to the workplace with some requirements to prevent further infection of COVID-19. Before returning staff to the office, JPIA has developed a policy that will guide the employees' and employer's actions to ensure a safe return to work. See policy on following pages.

RECOMMENDATION

That the Executive Committee approve the Infections Disease Return to Work Policy as presented.



Infectious Disease Return to Work Policy

I. OVERVIEW

The coronavirus disease 2019 ("COVID-19") is a respiratory disease that is spread from person to person, and can cause mild to severe illness. It is the goal of ACWA JPIA to take steps to reduce the spread of COVID-19 in the workplace and protect the wellness of our employees, especially our most vulnerable employee population. JPIA is committed to having all employees return to work *gradually*, in an *efficient* and *safe* manner following the closure of our workplace due to COVID-19. Further, JPIA is committed to treating all employees, applicants, contractors, visitors, and other third parties openly and honestly.

With this in mind, as employees return to the workplace following COVID-19 related closures, they will notice changes in the way the workplace looks as well as new protocols and requirements for all employees. We understand that these changes may create questions and be challenging, but JPIA's goal is to ensure the safety and security of our workplace and our employees as we navigate what the workplace will look like following the COVID-19 pandemic.

JPIA is following the guidelines set up by California Department of Public Health, CalOSHA, and County of Placer for returning staff to office workspaces. Many aspects of this policy are based on their recommendations.

This policy represents the JPIA's intention to inform all individuals of the risk of exposure to COVID-19, and sets forth the protocols and requirements the JPIA will enforce to protect employees and reduce the risk of spreading COVID-19 in the workplace.

Any questions regarding the information contained in this policy should be addressed to Andy Sells, CEO or Patricia Slaven, Director of Human Resources and Administration.

II. INDIVIDUALS COVERED BY THIS POLICY

This policy applies to all employees, applicants, contractors, visitors, and other third parties in connection with the JPIA's workplace.

III. JPIA COMMITMENT

Additionally, the JPIA will take actions to attempt to maintain a healthy work environment. Such actions include, but are not limited to, routinely cleaning and disinfecting throughout the day of all frequently touched surfaces in the workplace; nightly disinfecting by janitorial staff; discouraging employees from using other employee's phones, desks, offices, or other tools and equipment when possible; provide cleaning supplies for individuals to wipe down desks and cubicles, and other equipment after use; ensuring office configuration allows barriers between cubicles; reconfiguring break rooms to allow 6 foot distancing; limit number of individuals in one room at the same time. JPIA may send employees home, as the California Department of Public Health suggests, if they exhibit symptoms of COVID-19 while in the workplace.

IV. EMPLOYEE RESPONSIBILITIES

Each employee has a responsibility to prevent the spread of COVID-19. This includes adhering to the recommendations issued by the CDC for reducing the spread of COVID-19. Additionally, this policy requires the following actions be taken to reduce the spread of COVID-19 in the workplace:

- Individuals should stay home if not feeling well, no matter how minor the symptoms.
- Individuals are required to stay home if they have or suspect they have COVID-19.
- If an individual becomes ill due to COVID-19, they must immediately notify the JPIA (section IV below) and should return to the JPIA's workplace only after being released by a medical professional, and under the following circumstances:
 - As least 3 days (72 hours) have passed since the individual last had a fever without the use of fever-reducing medication; and
 - The individual no longer has respiratory symptoms (e.g., cough, shortness of breath); and
 - At least 7 days have passed since symptoms first appeared.
- If an individual is sent home due to symptoms of COVID-19, they can return to the JPIA's workplace only under the following circumstances:
 - As least 3 days (72 hours) have passed since the individual last had a fever without the use of fever-reducing medication; and
 - The individual no longer has respiratory symptoms (e.g., cough, shortness of breath); and
 - At least 7 days have passed since symptoms first appeared.
- Individuals must immediately notify the JPIA, even if they are well, if they have a close family member or friend, or someone who lives in their household, who has COVID-19. The JPIA may take action to limit the individual's potential for spreading COVID-19 depending on the relevant circumstances. Employees should monitor their health on a daily basis to ensure they remain free of COVID-19.
- Employees are required to practice proper hygiene in the workplace including regular hand washing with soap and water or, if water is not available, using alcohol-based disposable hand wipes or sanitizers, by covering their mouth and nose when coughing or sneezing, immediately washing or sanitizing hands, and avoiding touching their eyes, nose, or mouth.
- Employees should practice social distancing, and stay at least 6 feet apart from each other, when moving through the workplace.
- Employees are required to wipe down all equipment after use including copy machines, fax machines, coffee makers, microwaves, ice maker, refrigerators, etc.
- Staff are encouraged to eat lunch at their desk, and pack meals in insulated bags with ice to avoid use of refrigerators.

• Employees should call, e-mail, message, or video conference as much as possible rather than meet face-to-face.

Further, employees must adhere to the JPIA's return to work requirements as described further below.

V. RETURN TO WORK

It is the JPIA's desire for all employees to return to work following a workplace closure due to COVID-19. However, the JPIA also desires to protect the health and safety of our employees and others in the workplace. Further, the JPIA complies with the Americans with Disabilities Act (ADA), as amended by the ADA Amendments Act, and all applicable state and local fair employment practices laws, and is committed to providing a work environment that is inclusive and provides equal employment opportunities to all gualified individuals, including those with limiting conditions or disabilities.

With these principles in mind, the JPIA is setting forth the following return to work requirements for COVID-19-related purposes:

- Upon the re-opening of the workplace following a COVID-19-related closure, all employees will be required to self-screen before being permitted to return to the workplace. Self-screening includes temperature taking and reviewing possible symptoms of COVID before coming to work. JPIA reserves the right to conduct additional screening if necessary, including such screening as temperature testing and asking questions about potential symptoms. These testing/screening procedures will be in place as long as deemed necessary by the JPIA.
- All returning staff will have to complete TargetSolutions training modules on the following topics:
 - Coronavirus 101 What You Need to Know
 - o Coronavirus 105 Cleaning and Disinfecting your Workplace

VI. JPIA NOTIFYING STAFF

Where the JPIA receives information about an employee who is positive for COVID-19, the JPIA will take appropriate action to trace that employee's contact with other employees, including requesting information from the employee about recent contacts. The JPIA may notify other employees who had contact with the COVID-19 positive employee, but will not disclose the identity of the infected employee as part of this contact tracing process.

VII. DISCRIMINATION AND RETALIATION PROHIBITED

The JPIA strictly prohibits and will not tolerate any retaliation or discrimination against any individual based on the individual having COVID-19 or reporting potential exposure to COVID-19. However, the JPIA reserves the right to exclude a person with COVID-19 from the workplace if the JPIA finds that, based on relevant factors, such a restriction is necessary for the welfare of the individual with COVID-19 and/or the welfare of others within the workplace.

Any individual who believes that he or she has been wrongfully retaliated against or discriminated against for having COVID-19, reporting a potential exposure to COVID-19, exercising any rights under this policy, or for any other reason must immediately notify Human Resources.

VIII. CONFIDENTIALITY

COVID-19-related diagnosis information, responses to questions about potential symptoms before returning to work, information regarding an employee's body temperature, or other medical information reported to the JPIA is treated as confidential information. The JPIA is committed to complying with all applicable federal, state, and local laws that protect the privacy of persons who have undergone screening for, have been diagnosed with, or have been exposed to COVID-19. Every effort will be made to ensure procedurally sufficient safeguards are in place to maintain the privacy of individuals who have or have been exposed to COVID-19.

<u>ACWA JPIA</u> Dam Failure Liability Program June 1, 2020

BACKGROUND

The Dam Failure Liability Program (DFLP) first became operational in 1979 along with the Auto and General Liability Program (Liability Program). The program is a pass-through program, which means costs of the program are passed through to the participating members, plus a small administration fee. There are currently 15 members participating in the program.

CURRENT SITUATION

The carriers providing coverage for the DFLP are the same carriers used in the Liability Program. The carriers are expected to provide coverage. Over the years, as the JPIA has marketed the Liability Program there has been some resistance to provide the DFLP coverage. Staff has worked with our brokers to explore other carriers and markets to retain separate coverage for the DFLP. The information indicates there is no other coverage available at a reasonable price. Over the years, the limits have been reduced to the point that only two of the 25 dams covered have more than \$5 million in limits. More recently, the self-insured retention went from \$50 thousand to \$1 million.

The JPIA is currently reviewing options for the Liability Program renewal for the 2020-21 policy year that begins October 1, 2020. Using CWIF as an option in the renewal tower may limit our ability to maintain DFLP coverages in their current form.

Staff recommends that the current members of the DFLP be contacted to gage the level of interest in participating in the Program given that limits may be capped at \$5 million and the member's self-insured retention would be \$1 million. Pricing would be subject to current market conditions.

ACWA JPIA Significant Claims June 1, 2020

BACKGROUND

The Executive Committee has requested to be kept abreast of settlements on those claims that had been previously presented for authority. The following cases have been settled since this Committee's last meeting.

CURRENT SITUATION

Polk/Ingram vs. Rancho California Water District

This claim involved a main line that broke and sent water and debris into the air and onto the home/property. The water and debris damaged the home and its contents. The family had to be relocated to a rental home while repairs were completed. The claim was resolved for a total of \$220,589.89.

Laubham vs. South Coast Water District

This claim involved a sewage backup into a home due to blockage in the main line. This is a vacation home and was unoccupied. The claim was resolved for a total of \$263,903.51.

City of Santa Clarita vs. Santa Clarita Valley Water Agency (DOL 1/16/2020)

This claim occurred when the agency's 14" PVC water line broke and damaged the asphalt roadway and sidewalk. The claim was resolved for a total of \$239,393.37.

City of Glendale vs. Crescenta Valley Water District

This claim involved a break of the 8" water line that caused significant damage to the city's newly paved roadway. The claim was resolved for a total of \$392,633.40.
