Are there services covered before you meet your deductible ?	Yes. Preventive Care for In- Network Providers and some prescription drugs as listed on the MedImpact Safe Harbor List .	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible .
