Staff was having a difficult time entering the beds of the crew trucks to get the necessary tools and materials. The step to the bumper was high which could have led to a manual handling injury or a slips, trips, falls injury entering the bed of the crew truck.

A step receiver hitch was inserted into the tow hitch receiver of a crew truck. This step allowed staff to take a small step onto the step receiver hitch, and then enter the bed of the truck.

State whether the hazard was reduced with engineering controls, introduced a new administrative or work procedure, or relied on personal protective equipment to solve the problem.

While the hazard of entering the back of the pick-up truck has not been eliminated, the hazard has been reduced. The hazard was reduced with a substituted alternative.

This nomination promotes employees to enter the bed of the truck to load and unload materials. When staff places materials in the back of the truck from ground level, bad body mechanics are often used because the shoulders are not in a relaxed position. Industrial ergonomics was the special emphasis program in 2021 at EID, and staff were encouraged to find ways to decrease industrial ergonomic injuries. Chris was able to help the program, and also encourage other staff members to look for ways to decrease hazards in the workplace.

About three years ago the JPIA revised this program's description to encourage members with leading indicators of safety.

Below are questions or suggestions I have to strengthen this nomination.

1. Is the step fabricated or readily available on the market? [Ready available](#)
2. What is the rated capacity of the step? [Class III has a max tongue weight of 600lbs and class IV has a max tongue weight of 1000lbs.](#)
3. Can employees use three points of contact with the step? If so, a photo showing three points of contact would be great. [Yes, photos are attached.](#)

4. Did EID create or update a JHA for the step? If not, completing this ergonomic site survey worksheet for the use of the step would be a huge addition to the nomination. [No, maybe this is something we can do together when we observe this crew work.](#)
