Several Executive Committee members reported attending the CAJPA Conference in South Lake Tahoe earlier in September.

### <u>Vista Irrigation District Resolution for Walter "Andy" Sells</u>

Mr. Kuchinsky, representing Vista Irrigation District's Board of Directors, presented JPIA Chief Executive Officer Walter 'Andy' Sells with a Board Resolution honoring him as he retires after 33 years of exemplary service to the JPIA and its members, and his invaluable contribution to the insurance pool industry and California water communities.

# ACWA JPIA Executive Committee Resolution 2023-2 Commendation for Walter "Andy" Sells

Chair McDonald presented JPIA Chief Executive Officer Walter 'Andy' Sells with the highest commendation for his 33 years of outstanding service to the JPIA and its members. His dedication and leadership have been an important element in the development and success of the JPIA. Over the years, Andy has managed multiple departments, including claims and risk management, and was instrumental in the establishment of the Employee Benefits Department under the JPIA in 2012 and the creation of a captive, California Water Insurance Fund, in 2018.

### **PROGRAMS**

### Significant Claims report

Ms. Nogosek reported on liability claim settlements that had been previously presented for authority. The following cases have been settled since this Committee's last meeting:

### Groth et al vs. Santa Fe Irrigation District (4/2/2022)

This claim involved a broken water main that flooded a medical office building. Three medical offices sustained damage. All claims were resolved for a total of \$551,079.19.

### City of Chula Vista vs Otay Water District (8/12/2022)

This claim involved a 10' section of 16" PVC pipe that split and damaged the asphalt road. The claim was resolved for a total of \$166,446.09.

### State Farm Insurance vs Palo Verde Irrigation District (6/17/2021)

An unknown opened the district's head gate on one of their canals, which caused flooding to a home and yard. The claim was resolved for \$236,370.01.

### Bavaro Farming Co., Inc. vs Oakdale Irrigation District (8/4/2022)

The district's lateral overtopped due to human error. This caused flooding damage to multiple structures. The claim was resolved for \$155,789.54.

### Bianchi vs Oakdale Irrigation District (5/31/2021)

This claim involved a vehicle accident caused by the district's employee running a red light and striking the claimant's vehicle. The claimant sustained a traumatic brain injury, post-concussion syndrome, amnesia, headaches, temporomandibular joint dysfunction/resultant crown, depression, visual disturbances, and PTSD. The claim was resolved for \$225,000.00.

### Tapia vs Monte Vista Water District (2/4/2020)

This claim involved a vehicle accident caused by the district's employee making a left turn in front of the claimant's vehicle. The claimant driver and her two young children were injured as a result. The driver sustained serious injuries including a fractured wrist which required surgery and hardware. All claims were resolved for a total of \$750,000.00.

### **PERSONNEL COMMITTEE**

Personnel Committee Chair McDonald reported on the recommendations of the Committee from its meeting on September 6, 2023. Much discussion was held on clarifying the need for the new positions and their roles in the organization, as well as the JPIA 2023-24 Salary Schedule. Director Reed voted to abstain from the motions to approve the new positions and the JPIA 2023-24 Salary Schedule due to lack of information.

The CEO evaluation process and the optional add-ons were also discussed at length, specifically a potential conflict with hiring the same consultant to conduct the CEO evaluation process and to provide executive coaching.

Mr. Sells announced the Ms. Beatty has been elected to the AGRiP board. Ms. Beatty shared that the Strategic Planning Session (SPS) will be held in San Diego from January 29-30 to be facilitated by Mr. Rick Brush, Chief Member Services Officer, of PRISM. The theme for this meeting will be Measures That Matter which focuses on designing organizational value statements from the perspective of the membership and then using that information to fine-tune services and communications. Ms. Beatty added that the Executive Committee will be receiving SPS 'homework' in the next couple of months to assist them with gathering value statements, or information that can become value statements, from their own Districts as well as peers that also participate in JPIA programs.

# <u>ACWA JPIA</u> Emergency PERS Resolution (2023-3)

October 25, 2023

### **BACKGROUND**

CalPERS enacted legislation effective January 1, 2013, that a 180-day waiting period be required for all employees who retire from a public employer, in the public retirement system, from which they retired without reinstating from retirement, except under certain circumstances (G.C. 7522.56 and 21224).

One exception states: "The governing body of the public agency or the County Office of Education of the school employer presents CalPERS with a resolution, passed at a public meeting, that approves the appointment in which the employer has certified the nature of employment and that the appointment is necessary to fill a critically needed position before the 180 days has passed. The appointment may not be placed on a consent calendar."

### **CURRENT SITUATION**

JPIA has been in the process of transitioning to a variety of Risk Management Information Systems (RMIS) for the better part of the past 10 years. The RMIS is intended to consolidate data collected in the finance, member services, claims, risk management, training, employee benefits, and human resource departments. The RMIS software will be used by the JPIA's 401 member agencies and JPIA staff to analyze and allocate program premiums; capture, analyze and manage program renewal data; manage program risk exposures; target training opportunities and enhance communication between members and the JPIA.

Most recently, in early 2023, staff determined that the current system for which implementation had been in process for over a year, Ventiv Policy, was not sufficient to meet the needs of the JPIA. An engagement with Ventiv Policy had been initiated to replace both NavRisk and RiskConsole as the JPIA's primary RMIS. Upon the failure of the Ventiv Policy implementation, it was determined that in-house development of an RMIS system, with a combination of in-house and outsourced development staff and with Walter "Andy" Sells, JPIA's recently retired Chief Executive Officer, as the Project Manager, was the optimal course of action to ensure the JPIA obtained an RMIS system that would surpass the quality and functionality of its current systems, consolidate data and a variety of processes into one system, and significantly benefit members and staff upon completion and well into the future.

Walter "Andy" Sells, former Chief Executive Officer, retired as of September 29, 2023, has managed this project from the start. He is the most familiar with the data that will be collected, the processes that will be automated, the JPIA members' needs, the needs of each department within the JPIA, the RMIS program, and coordination of the project development with the IT department and contracted IT consultants. It is anticipated that

Mr. Sells will devote approximately 12 hours per week to the project until completion. It is essential that Mr. Sells continue to participate in the development and implementation of this significant JPIA project.

### **RECOMMENDATION**

That the Executive Committee pass a resolution, to certify to CalPERS, the emergency appointment of Walter "Andy" Sells as Project Manager for the ACWA JPIA pursuant to the exception to the 180-day waiting period under Government Code(s) 7522.56 and 21224.

### **RESOLUTION (2023-3)**

OF THE EXECUTIVE COMMITTEE OF THE ASSOCIATION OF CALIFORNIA WATER AGENCIES JOINT POWERS INSURANCE AUTHORITY (ACWA JPIA) APPOINTING A RETIRED ANNUITANT PURSUANT TO THE EXCEPTION TO THE 180-DAY WAITING PERIOD UNDER GOVERNMENT CODE(S) 7522.56 AND 21224

WHEREAS, in compliance with Government (Gov.) Code section 7522.56 of the Public Employees' Retirement Law, the ACWA JPIA must provide CalPERS this certification resolution when hiring a retiree before 180 days has passed since their retirement date; and

WHEREAS, Walter "Andy" Sells (CalPERS ID 2279534117) retired from the ACWA JPIA in the position of Chief Executive Officer, effective September 30, 2023; and

WHEREAS, Gov. Code section 7522.56 requires that post-retirement employment commence no earlier than 180 days after the retirement date, which is March 28, 2024 without this certification resolution; and

WHEREAS, Gov. Code section 7522.56 provides that this exception to the 180-day wait period shall not apply if the retiree accepts any retirement-related incentive; and

WHEREAS, the Executive Committee, the ACWA JPIA, and Walter "Andy" Sells certify that Walter "Andy" Sells has not and will not receive a Golden Handshake or any other retirement-related incentive; and

WHEREAS, the Executive Committee hereby appoints Walter "Andy" Sells as an extra help retired annuitant to perform the duties of Project Manager for the ACWA JPIA under Gov. Code section 21224, effective October 30, 2023; and

WHEREAS, the employment document between Walter "Andy" Sells and the ACWA JPIA has been reviewed by this body and is attached herein; and

WHEREAS, no matters, issues, terms or conditions related to this employment and appointment have been or will be placed on a consent calendar; and

WHEREAS, the employment shall be limited to 960 hours per fiscal year for all CalPERS employers; and

WHEREAS, the hourly rate paid to Walter "Andy" Sells will be \$100 per hour; and

WHEREAS, Walter "Andy" Sells has not and will not receive any other benefit, incentive, compensation in lieu of benefit or other form of compensation in addition to this hourly pay rate; and

THEREFORE, the Executive Committee of the ACWA JPIA resolves as follows:

- 1. The Executive Committee hereby certifies the nature of the appointment of Project Manager as described herein.
- 2. This appointment is necessary to fill the critically needed position of Project Manager for the ACWA JPIA by October 30, 2023.
- 3. Mr. Sells' expertise is needed to due to an ongoing Information Technology (IT) project designed to consolidate data collected in the finance, member services, claims, risk management, training, employee benefits, and human resource departments to a Risk Management Information System (RMIS). The RMIS software will be used by the JPIA's 401 member agencies and JPIA staff to analyze and allocate program premiums; capture, analyze and manage program renewal data; manage program risk exposures; target training opportunities and enhance communication between members and the JPIA. The target completion date is late 2024. Mr. Sells has managed this project from the start. He is the most familiar with the data that will be collected, the processes that will be automated, the JPIA members' needs, the needs of each department within the JPIA, the RMIS program and coordination of the project development with the IT department and contracted IT consultants.

# ACWA JPIA Executive Committee Election Process

October 25, 2023

### **BACKGROUND**

Eight of the nine Executive Committee member positions each have four-year terms. Elections to fill these terms are held at the Spring Board of Directors meeting every other year.

At the March 23, 2023 meeting, the Committee reviewed a proposal to revise the Executive Committee election rules. At that time, and due to the proximity to an election, the Executive Committee tabled the conversation and requested it be revisited at a later time. Since the next Executive Committee election will not take place until May 2025, staff would like to re-visit reviewing the proposed changes.

### **CURRENT SITUATION**

The JPIA's Board of Directors Manual, Section 8, Election Rules, Rule #8 states that "If candidates for office do not receive a majority of cast votes, a subsequent ballot is held with one more candidate's name than the number of vacancies to be filled; i.e. the **three** candidates who receive the most votes to run for **two vacancies**; or, the **two** candidates who receive the most votes to run for **one vacancy."** 

In March, the proposed change was, as follows:

If candidates for office do not receive a majority of cast votes, a subsequent ballot is held with one more candidate's name than twice the number of candidates than the number of vacancies to be filled; i.e. the three four candidates who receive the most votes to run for two vacancies; or, the two candidates who receive the most votes to run for one vacancy. If upon the second vote, the candidates for office do not receive a majority of cast votes, a subsequent ballot is held with one less candidate than the prior ballot. This process will continue until there are candidates who receive a majority of cast votes for the number of vacancies to be filled.

The full Executive Committee election sections from the Bylaws and Board Manual have been included here for the Committee's reference, should the Committee wish to consider additional changes.

# Section 8 — Executive Committee Elections

### **Executive Committee**

Eight of the nine Executive Committee member positions each have four-year terms. Elections to fill these terms are held at a spring Board of Directors' meeting, every other year. The ninth Executive Committee member position is an ex-officio position, which is held by the current ACWA Vice President.

# **Nominating Procedures**

Approximately 120 days prior to an election, members are notified of the upcoming election. The notice includes date and place of election, positions and terms of office to be filled, incumbent office holders, and the nominating procedures.

Candidates are required to be their district's director representative on the JPIA's Board of Directors in order to be nominated to the Executive Committee. Also, the member district must participate in all of the JPIA's Programs: Liability, Property, Workers' Compensation, and at least one of the Employee Benefits programs. Nominations must be by resolution and three other current JPIA members must, by resolution, also concur in the candidate's nomination. These resolutions must be submitted to the JPIA office no later than 30 days prior to the date of the election. This is the sole method for placing candidates into nomination for Executive Committee positions.

Members have until 30 days prior to the election to submit their nominating resolutions, three concurring in nomination resolutions, and statement of qualifications for their candidate.

Fourteen days before the election, a final notice of the upcoming election is sent. This notice includes the date, time, and place of the election; name and district of all qualified candidates; the candidates' statements of qualifications; and the election procedures and rules. This notice is sent out as part of the Board of Directors' meeting packet to those who have requested a packet. It is also posted on the JPIA's website.

# **Election Rules**

- 1. The ballots with the names of all qualified candidates are distributed at the entrance to the meeting room before the meeting is called to order.
- 2. Only the Board of Directors member or Alternate Board of Directors member may obtain the ballot.
- 3. Only those JPIA member agencies with either a Director or Alternate Director present may vote. **Proxy voting is not permitted.**

# **Board of Directors' Manual Excerpt**

- 4. Additional color-coded ballots are supplied for any necessary subsequent balloting.
- 5. Ballots are counted by the three (3) appointed election inspectors and the results are announced at the board meeting.
- 6. All nominated candidates run for election at the same time. Those candidates with the greatest majority of votes are elected to the longest term of office.
- 7. Since the Bylaws require a **majority vote** to elect Executive Committee members (Article II, Section 9), subsequent ballots may be needed if the required number of candidates do not receive a majority of votes from the members present and voting.
- 8. If candidates for office do not receive a majority of cast votes, a subsequent ballot is held with one more candidate's name than the number of vacancies to be filled; i.e. the **three** candidates who receive the most votes to run for **two vacancies**; or, the **two** candidates who receive the most votes to run for **one vacancy**.
- 9. If a tie vote occurs in a preliminary ballot (majority of votes not obtained by required number of candidates), the tied candidates are included in the subsequent ballot if they have received the required number of ballots as determined in seven above.
- 10. If a tie vote occurs in a final ballot (two candidates for one office or position) the presiding officer will designate one of the tied candidates to call a coin toss, by the presiding officer, to determine the election results.

# **JPIA Bylaws Excerpt**

### Article III — Executive Committee

### Section 1. Composition, Selection and Term of Office.

The Executive Committee shall consist of nine (9) members, including eight (8) members elected by the Board of Directors from its voting Members and the Vice President of the Association of California Water Agencies, who shall be an *ex officio* member of the Executive Committee. Commencing with the first Board of Directors' meeting held in 2013 four (4) members shall be elected in every odd-numbered year and shall serve four-year terms until their respective successors are elected. Commencing with the first Executive Committee meeting held after the 2013 Board of Directors' election, the Executive Committee shall appoint two of its members to serve two-year terms as President and Vice President of the Board of Directors. There shall be no limit to the number of two-year terms a person may serve as the President or the Vice President of the Board of Directors. All members of the Executive Committee, except the Vice President of the Association of California Water Agencies, shall be Directors of Members which participate in the ACWA/JPIA's Liability, Property, Workers' Compensation, and at least one of the Employee Benefits Programs.

In order to prevent any JPIA Member from having more than one vote on the Executive Committee, a JPIA Member Entity shall not have more than one vote regardless of the number of representatives sitting on the Executive Committee.

Upon their adoption by the Members, these four-year terms shall be implemented as agreed upon by the Executive Committee.

The President, or in his or her absence, the Vice President shall serve as Chair of the Executive Committee.

### Section 2. Vacancies.

(a) Existence of Vacancies. A vacancy or vacancies in the Executive Committee shall be deemed to exist in case of the death, resignation, expiration of term, termination of membership on the Board of Directors, removal of any member by the Board of Directors, declaration of unsound mind by order of court, conviction of a felony, increase in the authorized number of members, or if the Board of Directors fail, at any annual or special meeting of the Board at which any members of the Executive Committee are elected, to elect the full authorized number of members to be voted for at that meeting. A vacancy may also be deemed to exist because of the unexcused absence of a member of the Executive Committee, other than the Vice President of the Association of California Water Agencies, from two (2) consecutive meetings thereof, and may be cause for removal of said member by the Executive Committee.

# **JPIA Bylaws Excerpt**

- (b) Vacancies Filled by Executive Committee. Vacancies in the Executive Committee, except for a vacancy created by the removal of any member by the Board of Directors and a vacancy in the office of Vice President of the Association of California Water Agencies, may be filled on an interim basis by a vote of the majority of the remaining voting members, though less than a quorum, or by a sole remaining voting member of the Executive Committee, and each member so appointed shall hold office until his or her successor is elected at the next election meeting of the Board of Directors.
- (c) Vacancies Filled by Board of Directors. The voting members of the Board of Directors may elect a member of the Executive Committee at any time to fill any vacancy or vacancies or seat filled on an interim basis by the Executive Committee. A vacancy on the Executive Committee created by the Board of Directors removing a member may be filled only by the vote of a majority of the representatives of Members at a Duly Constituted Board Meeting at which a quorum is present.

# ACWA JPIA Creation of Walter "Andy" Sells Risk Management Award October 25, 2023

### **BACKGROUND**

Staff seeks input from the Executive Committee on the creation of a Walter "Andy" Sells Risk Management Award. Ideally, the award would relate to one of Mr. Sells' core traits and strong beliefs in the world of risk management and pooling.

### **CURRENT SITUATION**

Walter "Andy" Sells, former JPIA Chief Executive Officer, recently retired from the JPIA after serving 33 years. His dedication and leadership have been an important element in the development and success of the JPIA. Over the years, Andy managed multiple departments and was instrumental in the establishment of the Employee Benefits Department under the JPIA in 2012 and the creation of the captive, California Water Insurance Fund, in 2018.

Mr. Sells was known for being innovative. He was the architect of the JPIA's current Retrospective Premium Adjustment process and the creator of the JPIA's current Catastrophic Loss Fund model which is unique in the California risk pooling space. He championed each member receiving an annual risk assessment and the JPIA's awardwining C2E Program, which he then backed with the current Risk Control Grant Program. He kept workers' compensation, property, and liability claims handling inhouse and spearheaded bringing employee benefits in-house as well. Many staff at JPIA live by Andy's motto, "how does this reduce claims and help the JPIA?"

With regard to creating a risk management award, some options might be to create an award based on innovation proven via sustainability. Another option might be to create a scholarship in Andy's name that would cover the cost for a member to attend a relevant risk pooling conference such as CAJPA, AGRIP, PARMA, or PRIMA.
