Geremy noticed during the rainy season the painted areas of the newly purchased trailer #24 were slippery when wet. He investigated at different products and found the Rhino Liner used on the back of the District's leak trucks is not slippery when wet. He recommended applying Rhino Liner on the trailer walking surfaces and it was approved. The trailer's painted areas are now covered in Rhino Liner and is no longer a slip hazard.

Staff took the trailer #24 to a shop that applies Rhino Liner . The shop prepared the painted walking surfaces on the trailer and coated them with the non-slip product. This product is used in select areas on most of our trucks.

The wet or dusty condition slip hazard on the trailer's walking surfaces was reduced or eliminated with Rhino Liner applied as an engineering control.
